### Veterans Affairs & Rehabilitation

One of the four pillars of the Legion, the Veterans Affairs & Rehabilitation Division is dedicated to the timely and compassionate delivery of benefits – including health-care services – earned by U.S. military veterans. One of the division’s marquee programs is the Department Service Officer School, which provides accredited training for Legion service officers throughout the nation. The curriculum for these schools includes education on veterans law, as well as changes in the veterans-benefits claims and appeals process.

The Legion provides staff representation at the Board of Veterans Appeals in Washington to help veterans appealing a decision to navigate through the maze of regulations and paperwork relevant to their cases. The VA&R national staff conducts regular site visits to VA medical facilities, and produces VBC site visit reports - formerly referred to as the “System Worth Saving” report - for Congress and others.

The division is the Legion’s eyes and ears in Washington about all issues related to VA, particularly benefits and health care. The division also offers representation to veterans dealing with discharge disputes and correction of military records; and administers the Legion’s involvement with VA Volunteer Services, which provides countless hours of cost-free staffing at VA facilities nationwide.

The House of Representatives passed the VA Accountability First and Appeals Modernization Act of 2016, a bipartisan legislation that would reform the U.S. Department of Veterans Affairs appeals process and reduce wait time for veterans’ claims.

American Legion National Commander Charles E. Schmidt is urging Legionnaires to reach out to Washington and ask that they “pass appeals modernization now! Tell Congress you expect both parties to work together responsibly to pass the legislation, which includes a simple and fair appeals process that provides veterans and their families their earned benefits in a timely manner.” The legislation is awaiting a vote in the Senate.

What have you done for a veteran today? Do you need any ideas or inspiration to come to our meetings - give me a call, I promise not to burn you out or put too much guilt on you.



We need your input, your ideas and your dues - but most of all our nation’s Veterans need your help and encouragement!

We have several assisted living facilities in our area. Every one of them have veteran residents. I’m sure they would welcome a visitor that speaks their language or who will just listen to the stories they like to tell. We have students in schools that like to hear from veterans - many don’t know anything about why we went to WAR, who started a war, who ended a war! Many have no idea about how many wars and police actions and conflicts that have taken place, etc. The American Legion publishes tons of brochures that students would probably like to have. Teachers will welcome us if they know we will present truthful information in school approved vocabulary and not bar room language or unsupported opinions. I want to help you help others - please challenge me!

Dear Fellow Veterans and Auxiliary Members,

While in the Marine Corps SGT Ramirez served two tours to Afghanistan. His first tour started in September 2011 and his second began July 2012. This boy was one of the lucky ones; he came back in one physical piece. Unfortunately, many of us are far too familiar with the perils of war, the loss of life, and the effects on our health.

When SGT Ramirez came home, he faced a big disappointment. The foundation of his home had literally started to sink into the ground. Assessing the situation, he met with multiple contractors - all of which had the same conclusion, "It has to be torn down and you have to start over". They tried to refinance with a renovation loan as they felt this was the only way they could start over. Tragically, they were not able to get the much needed loan.

Bradley Ramirez and his wife with their three kids have had to move to an apartment because the home became unsuitable for living. Now, they not only have to pay for the apartment but also the mortgage on a home that they cannot live in.

Civilian Nancy Green from Wells Fargo will be leading this mission 256-990-2448. As fellow Soldiers, Marines, and Seamen—we are her troops. The mission is called Project AVE C and operations will be run through the Legion at Post 112. Your post contact is Shell Underwood 706-508-9290.

The Mission has three separate goals. If we are able to raise \$15,000 we begin construction on the property. If we raise \$35,000 we can rebuild his entire home.

*Our current community project team leaders include: Cary Coker, John's Lumber, CWT Construction, Sherwin Williams, Double A Guttering, Nature's Way, the American Legion Post 112, Habitat for Humanity, Shaw Industries, Rebuilding HOPE Ministries and Modern Woodmen of America: Shell Underwood. \_\_\_ A. I agree to abide by all parade rules, including, but not limited to, the rule that requires that no object, including candy, be thrown from moving units in the parade. Instead, our organization agrees to abide by the rule that any object, such as candy (**will be distributed by an adult walking beside the unit by handing the object to the people on the curb**). Our organization understands that this rule is being imposed to prevent adults or minor children from running out into the street to retrieve an object, such as candy, and accidentally moving into the path of moving units in the parade. **GA Code Section 16-7-43, Littering**

\_\_\_ B. I agree that a truck or trailer shall transport all non-street legal vehicles the parade assembly site before being unloaded. Non-street legal vehicles shall not be operated on the city streets before or after the parade. **GA Code Section 40-7-3, Off Road Vehicles.**

I agree that no motor vehicle shall be driven upon any city street by any person under the age of 16 (sixteen) years of age; provided a person who is at least 15 (fifteen) years age may operate a vehicle as authorized by law. City Code Section 114-4, Minimum Age of Operator of Vehicle. **GA Code Section 40-5-24.**
